# B. Background:

Bangladesh, a South Asian country with a population of over 163 million, has experienced several incidents of mob lynching and hate attacks caused by the spread of inaccurate and misleading information on Facebook. For example, a series of mob attacks killed eight people in July 2019 after false rumors about child abduction spread online. In this circumstance, EMK Center believes the upskilling of local community to prevent spread of misinformation.

## C. Purpose of the Assignment:

To prevent the spread of misinformation in remote areas of Bangladesh by providing necessary skills to identify misinformation, and strategies to work for peace building in Chattagram area.

## D. Scope of Work:

- Training 50 young students from Chattagram, and Cox's Bazar and they will reach 1000 stakeholders through 5 community projects to counter radicalization and fake news or disinformation.
- ii) Supervising all five community projects in Chattagram division.
- iii) Produce a video content on the training and projects.

# E. Deliverable:

- 1. Coordinate and organize the training program on preventing misinformation and peace building for 50 people
- 2. Design a curriculum for the training program on preventing misinformation and peace building for EMK Center

3. Submit a final report following discussion and feedback from EMK Center

# F. Duration of the assignment:

The task is expected to be completed within 60-days from the date of signing the contract. The individual/firm, therefore, is required to prepare and submit the entire plan in a way that allows the achievement of all deliverables within 30-days period.
